

Article 35 of Order 07-95 states: "The insurer is not liable for property that is damaged, lost, or. 1 destroyed due to: o a) Insufficient or poor packaging by the insured. o b) An inherent defect in the insured object, unless otherwise agreed." Thus, excluded risks can be divided into two categories: .absolutely excluded risks and risks excluded unless otherwise agreed
