The analysis reveals that exports have a strong and statistically significant positive relationship with Japan's GDP, suggesting that export growth is a key driver of economic expansion. Overall, the findings highlight the critical role of exports in Japan's economic growth, while suggesting that inflation and unemployment may be influenced by other complex, unobserved factors The regression model accounts .for 96% of the variation in GDP, indicating a high explanatory power of the selected variables
