The necessity of budget deficit is caused to create the money supply or to satisfy demand for savings in excess of what can be satisfied by private investment. Budget deficit that caused by a huge expenditure in the public sector can increase the economic growth of that particular country, because there will be more infrastructure and creates a market for business output. In other words, budget deficit permits the .private sector to accumulate net worth
