

Lags and Policy Implementation If policymakers could shift the aggregate demand curve instantaneously, activist policies could be used to move the economy immediately to the full-employment level, as we saw in the previous section. The legislative lag represents the time it takes to get legislation passed to implement a particular policy. The legislative lag does not apply to most .monetary policy actions, such as the lowering of interest rates. 1.2.3
