At this point it establishes necessary IT systems to support strategic business processes as well as management reporting and review capabilities. 4. **Monitor.** The company monitors performance to ensure processes meeting objectives and provides feedback to operating managers to continuous improvement. 5. **Adapt.** The company evaluates the effectiveness of its strategy, conducts profitability analytics, tests the cause-and-effect assumptions of the strategy, and identifies potential alternatives
