

The ratios show a gradual decline from 2022 to 2025. Although the bank remains stable, the downward trend indicates weakening capital strength. Tier 2 capital reduced significantly over time. CET1 decreased from 16.04% to 13.22%. Total capital also declined from 16.68% to 15.18%
