Financial statements consist of a series of assertions by management, auditors must obtain sufficient competent audit evidence about each material financial statement assertion. Audit evidence is gathered by the auditors to assess both inherent and control risk and to restrict detection risk, Auditor risk is the risk that the auditors will issue an unqualified opinion on financial statement that contain material .(accounting principles (GAAP)
