The law of diminishing marginal product states that as more units of a variable input (labor in this case) are added to fixed inputs (capital, space, etc.), the marginal product of the variable input will eventually decrease. This is because adding a fifth worker results in a negative marginal product, meaning the .additional worker reduces overall production
