To influence monetary policy, the Fed targets changes to the fed funds rate, which is the interest rate on overnight loans of reserves among banks. Through its open-market operations, the Fed influences the amount of reserves in the banking system. When the Fed purchases Treasury securities on the open market, reserves tend to increase agreater supply of reserves puts downward pressure on the fed funds .rate, leads to an increase in the money supply
