

To influence monetary policy, the Fed targets changes to the fed funds rate, which is the interest rate on overnight loans of reserves among banks. Through its open-market operations, the Fed influences the amount of reserves in the banking system. When the Fed purchases Treasury securities on the open market, reserves tend to increase. A greater supply of reserves puts downward pressure on the fed funds rate, leads to an increase in the money supply
