In 1957, one of the strongest financial institutions in the Kingdom of Saudi Arabia, Al Rajhi Bank, was established in the Kingdom of Saudi Arabia. With total assets of 710 billion Saudi riyals, it is the largest bank in Saudi Arabia and the Middle East and among the largest banks in the world by market capitalization with a workforce including about 9,300 workers.
