

The United States and most other nations today have mixed economics. In such an economy, government expenditures typically amount to between one-quarter and one-half of GDP. Taxes absorb at least one-quarter of national income in the typical mixed economy, and governments usually regulate private economic activities and use taxes and the subsidies to affect incentives to use resources.
