In preparing International Accounting Standards, the International Accounting Standards Committee follows agreed procedures, as follows: 1– Selecting a subject and subjecting it to detailed studies by a major committee The project is charged with winning a draft standard relating to a specific topic of study This project was presented by the International Accounting Standards Board.
