The banking industry exists primarily to mediate the asymmetric information problem between saver–lenders and borrower–spenders, and banks can earn profits by capturing economies of scale while providing this service. In situations where the asymmetric information problem is not severe, the money markets have a distinct cost advantage over banks in providing short–term funds
