Four hundred samples were characterized and analyzed from individuals aged 1 month to 80 years, with a median of 6 years from 283 unrelated families. The commonest genotype was homozygosity for the polyadenylation–1 mutation (?PA–1?/?Most (90.8%) were Kuwaiti nationals. The frequency of the ?0 (–– MED) allele was 0.017.
