

A)–Internal audit: Internal audit means a continuous and systematic investigation of the accounting, financial and other operations of a concern by specially assigned staff in the organization .Entities are recently increasingly contracting with independent public accounting firms or other outside professionals to perform internal audit traditionally conducted by internal auditors.
